**PARTICIPANT RULES OF CONDUCT AND RELEASE OF LIABILITY  
PLEASE READ BEFORE SIGNING**

**Public Conduct, Sportsmanship and Competitive Integrity:** Angler agrees that the integrity and competitive honesty of fishing contests is paramount to any bass fishing tournament circuit's continued existence and success. Anglers compete in Wild West Bass Trail (WWBT) contests at the sole discretion of WWBT. The Wild West Bass Trail reserves the right to refuse service to any potential Angler and enforce its tournament rules at its discretion. Anglers are expected to conduct themselves in accordance with the highest standards of morality, honesty, fair play and sportsmanship and will not do anything which shall be detrimental to WWBT, its sponsors, or competitive bass fishing in general. Anglers agree to conduct themselves, at all times, with regard to public conventions and morals. Angler agrees not to engage in any conduct that will reasonably tend to degrade himself/herself or bring WWBT into public hatred, contempt, or ridicule or tend to offend the fishing community or integrity of competitive angling. Angler agrees that this provision is necessary to protect WWBT's goodwill in the community in which the Angler represents it and to protect the profitability and competitive integrity of WWBT's business. WWBT may ban any member from any contest(s) for a serious or intentional violation of any law, rule, regulation, constitutional provision, bylaw, or any act of dishonesty, theft or misappropriation of WWBT property, moral turpitude, insubordination, or any act injuring, abusing, or endangering others.

In consideration of being allowed to participate in any way in the WWBT fishing tournaments for the year 2020 the below signed, acknowledge, appreciate and agree that:

1. The risk of injury from the activities involved in tournament fishing is significant, including the risk of permanent injury or death and while particular rules, equipment and personal discipline may reduce the risk, the risk of serious injury does exist, and
2. I knowingly and freely assume all such risks, both known and unknown and assume full responsibility for my participation and
3. I agree to comply with the terms and conditions of participation, and

4. I, for myself and on behalf of my heirs, personal representatives and next of kin, hereby release, indemnify and hold harmless the WWBT, its officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors and advertisers, and if applicable, owners and/or lessors of premises used to conduct the event ("Release") with respect to any and all injury, disability, death or loss or damage to person or property, loss of income or future income, whether from negligence or otherwise, to the fullest extent of the law.
